# Directions to Engineering Resource Group, Inc. Office

## Via Garden State Parkway northbound

- Exit Parkway at Exit #142 (keep right at toll). Follow signs for Route 78 West.
- Follow 78 West for 4 miles. Take Exit #48 for Route 24 West (to Morristown, Springfield).
- Follow Route 24 West to end (about 10 miles). Follow signs for Route 287 North.
- Once on Route 287, keep right, and exit at next exit (#39) for Route 10.
- On exit ramp, keep left, following signs for Route 10 West (towards Dover).
- Follow Route 10 West for 2 ½ miles total. At third light (Powder Mill Road), keep right.
- Go through light, and exit immediately onto ramp for Powder Mill Road South.
- Follow ramp and go through light, crossing Route 10.
- Take your first left onto Gibraltar Drive into strip mall complex.
- We are the second building on the left (#101), third floor.

## Via Route 80 Westbound:

- Route 80 West to Exit #43. Ramp will be about 3 miles long.
- At end of ramp, follow signs for Route 287 South towards Morristown.
- Merge onto 287 South and move over to the right.
- Take Exit #39B for Route 10 West (towards Dover).
- Follow Route 10 West for 2 ½ miles total. At third light (Powder Mill Road), keep right.
- Go through light, and exit immediately onto ramp for Powder Mill Road South.
- Follow ramp and go through light, crossing Route 10.
- Take your first left onto Gibraltar Drive into strip mall complex.
- We are the second building on the left (#101), third floor.

#### **Via Route 80 Eastbound:**

- Route 80 East to Exit #28 (Ledgewood / Lake Hopatcong). Merge onto Route 46 East.
- At 2<sup>nd</sup> light, keep right and continue straight onto Route 10 East. Follow Route 10 for 10 miles total.
- Turn right at the light onto Powder Mill Rd (after Parsippany Inn & Exxon station).
- Make first left onto Gibraltar Drive into strip mall complex.
- We are the second building on the left (#101), third floor.

#### Via NJ Turnpike:

- NJ Turnpike to Exit 14. Pay toll and follow signs for Route 78 West.
- Take 78 West for 10 miles. Exit at Exit #48 for Route 24 West.
- Follow Route 24 West to end (about 10 miles). Follow signs for Route 287 North.
- Once on Route 287, keep right, and exit at next exit (#39) for Route 10.
- On exit ramp, keep left, following signs for Route 10 West (towards Dover).
- Follow Route 10 West for 2 ½ miles total. At third light (Powder Mill Road), keep right.
- Go through light, and exit immediately onto ramp for Powder Mill Road South.
- Follow ramp and go through light, crossing Route 10.
- Take your first left onto Gibraltar Drive into strip mall complex.
